9.25. Roofs:

Roofs must be compatible with the home. Neutral, earth tones will be considered. Solid Orange, Blue, Red or Green shingle colors will not be considered on a case-by-case basis. Changes in roofing material or shingle color require approval. Can upgrade to Architectural Shingles

9.25.1. Turnberry Pointe Roofing: It is acknowledged that the Turnberry Pointe Neighborhood has standard roofing tiles for all the homes. Owners in the Turnberry Pointe Neighborhood do not need to request approval for a re-roof, so long as the following specifications are adhered to:

9.25.2 Turnberry Pointe Roof Tile: Boreal USA Concrete Roof Tile IMPC56254, Mandarin Sun. (Original roof tile was Monier Lifelite Mauve. Monier Lifetile was acquired by Boreal USA in August 2010 and the original color Moonlite Mauve was apparently discontinued). (See Appendix VIII)
