A copy of the tenant lease agreement is required before the cards can be issued to the tenants.

Per Florida Statutes 720.305, Each member and the member's tenants, guests, and invitees, and each association, are governed by, and must comply with, this chapter, the governing documents of the community, and the rules of the association. A fine or suspension may be imposed for failure to comply to the Association's Rules and regulations.

An association may suspend, for a reasonable period of time, the right of a member, or a member's tenant, guest, or invitee, to use common areas and facilities for the failure of the owner of the parcel or its occupant, licensee, or invitee to comply with any provision of the declaration, the association bylaws, or reasonable rules of the association.

If a member is more than 90 days delinquent in paying a monetary obligation due to the association, the association may suspend the rights of the member, or the member's tenant, guest, or invitee, to use common areas and facilities until the monetary obligation is paid in full. The card and phone app will be deactivated upon a member's suspension of rights to use the common areas.
